## **United Nations General Assembly**

Agenda item: Measures to eliminate international terrorism

The General Assembly,

*Recalling* international global antiterrorism strategy and international convention for the prevention of organized crime,

Conscious terrorism is a grobal phenomenon, not only in our own countries,

*Aware* the number of attacks by terrorism are still more than 8000 and there are still more than 10000 people who died by terrorism,

Deploring the indiscriminate killing of innocent people by terrorism,

Emphasizing in order to counter them, it is essential to build a global cooperative system,

*Believing* many regions and countries with high terrorist threat do not have sufficient capacity to respond to terrorism,

*Declaring* it cannot perform an attribution of responsibility by the standard that is vague in the country which does not have a management capability enough,

*Emphasizing* in order to eradicate terrorism from around the world, it is essential to provide technical developing countries with low capacity to respond to terrorism,

*Affirming* in addition, all countries must endeavor to improve their capacity to manage such matters as immigration inspection in order to prevent terrorism,

*Deploring* a way of the interpretation about definition of the terrorism varies according to each country or engine and the produced definition of the international agreement do not exist,

*Regretting* people affected by the radicals on the Internet participating in the terrorist

organizations such as ISIL,

*Noting with deep concern* increasing terrorists for the purpose of the terrorism animation diffusion on SNS,

*Confident* leading to future terrorism extinction to aim at the IS destruction becoming the hotbeds of terrorism,

Convinced that the current gun control is inefficient to maintain international peace,

- 1. *Calls upon* doing countries capacity buildings to abolish terrorism in the whole international community;
- 2. *Decides to* set the following guidelines about skills and financial assistance;
- (a) CTC shall lays down the definition about countries which need supports,

(b) oblige to write report about the usages of the fund and the terrorism management situation of the own country to supported country,

(c) only for the country that submitted a report to about the usage of the fund, financial support or a technical professor shall be got through CTC,

(d)when CTC judges that fund were contributed is not used for an original purpose, the country will be warned,

(e) the meeting hold between supported countries and recipient countries to share reports about the terrorism control situation once in six month,

- 3. *Calls upon* to manage it about attribution of responsibility to the nation of the terrorist in each domain after having established a national definition to investigate responsibility;
- 4. *Supports* FATF conducting international cooperation in money laundering measures or terrorism fund measures;
- 5. *Calls upon* to hold conference for the purpose of discussing about the establishment of the definition of world common terrorism or future counterterrorism in CTC;
- 6. *Invites* Obliging the account info of SNS in case of the control of the terrorist organization activity in the Internet and the monitoring of dangerous ideas, the visa application;
- 7. *Recommends* to corporate with a company to deal with use of the Internet in the terrorism purpose;
- 8. *Reaffirms* to corporate between nations is essential to make Funds source blocking

resolution work;

- 9. *Urges* to make common throughout the world by the extradition method, and add the article which did the standard of the political offense that it is clear;
- 10. *Decides* to manage it about attribution of responsibility to the nation of the terrorist in each domain after having established a national definition to investigate responsibility;
- 11. *Decides* fixing a border with simple unreasonable use of armed force for the terrorism, and severe economic sanctions shall be added for the country when it is the use of the right of self-defense by CTC;
- 12. Urges be based on the closed local jurisdiction if act of terrorism happen, the Security Council is to be set up, if you need use of force keep a period;
  a) "individual terrorism treaty" on all treaties of" we can't ensure the safety of the people, if it is violated, protect the people and people from terrorists Recognize the use of armed forces and armed attacks in order to protect the people and people from terrorists, these acts are until the Security Council takes measures necessary to maintain international peace and security, the measures taken by the Member States shall be immediately reported to the Security Council and reports shall be submitted in those actions. Adding the text ",

b) *Add* the above-mentioned texts that allow other states to conduct acts of terrorism, as well as laws, to force the use of force if unavoidable,

c) Use of force does not include nuclear or poison gas,
