## **United Nations General Assembly**

Agenda item: Measures to eliminate international terrorism

The General Assembly,

*Emphasizing* that it is difficult for a nation to completely prevent the occurrence of terrorism in its own country, recognizing the need to take all measures to prevent or reduce the damage from terrorism,

*Deeply concerned* that the abuse of the right to self-defense will threaten the international order and thus its security  
*Emphasizing* that importance of punishing criminals by law rather than military retaliation for terrorist attacks,

*Keep in mind* that Social Networking Service (SNS) is a hotbed of terrorism spread,

*Pay attention* to the importance of regulating the funding sources of terrorist organizations,

*Promote* the development of common international rules on immigration

1. *Calls upon* for the following regarding the attribution of responsibility to the nation of the terrorists;
  - a) Counter-Terrorism-Committee (CTC) investigates the attribution of responsibility to the nation,
  - b) In the case of private acts of terrorism, there is no exception in the following cases that responsibility belongs to that nation,
    - i. If the nation has substantial control over private acts of terrorism,
    - ii. If the nation has officially approved or directed its acts of terrorism,
2. *Confirming* that CTC investigates the presence or absence of national involvement;
3. *Encourages* share information of terrorism that each country has by CTC;
4. *Calls* for the following things to be done in order to tighten the control of entry and exit of each country
  - a. countries to be as strict as possible in immigration control,
  - b. multilateral support by developed countries when developing
  - c. as for assistance, promote bilateral negotiations to provide appropriate assistance that meets the needs of each country

5. *Calls upon* compliance with the requirements for the right to self-defense:
  - a) The requirements for the exercise of the right to self-defense described in Article 51 of the Charter of the United Nations to comply
  - b) If any of the following is recognized internationally:
    - i) That the aggressor is a nation,
    - ii) That the nation aroused, encouraged, and supported the aggressor,
6. *Requests* the following to legally judge terrorism offenders worldwide:
  - a) Utilization of International Criminal Justice Cooperation,
  - b) Differentiation of terrorism and political crimes,
  - c) Participation and utilization of the International Criminal Police Organization (ICPO),
  - d) Conclusion of bilateral treaty;
7. *Recommends* limiting the promotion of terrorism on SNS;
8. *Promotes* terrorism enlightenment using media etc.;
9. *Promote* information sharing on drugs and weapons smuggling in CTC;
10. *Promote* the regulation of drugs and weapons smuggling;
11. *Promote* the development of common international rules on immigration;
12. *Promote* strengthening of border security;
13. *Calls for* the implementation of stricter departure procedures:
  - a) Offers aid in technology from developed countries to developing countries
  - b) Observes those with a criminal record using latest technology such as facial recognition
  - c) Shares the most recent information on the forgery of passports
  - d) Increases the punishment for the possession of illegal items;
14. *Requests* the ratification of The Rome Statute of the International Criminal Court;
15. *Affirms* that the United Nations (the UN) needs to confirm a unified definition of terrorism in order to fight it cooperatively;
16. *Condemns* the collective terrorist activities over the past decades and *recognizes* the many deceased;
17. *Deplores* Member States that have taken part in terrorist activities or have supported terrorist groups;

18. *Recommends* Member States to ratify the Declaration on Measures to Eliminate International Terrorism and other individual treaties against terrorism, and to follow the procedures stated;
19. *Emphasizes* that a generalized international treaty on combatting terrorism should be ratified in the future;
20. *Urges* the United Nations Global Counter-Terrorism Committee (CTC) to research the information below in the instance of a terrorist attack:
  - a) where the base and the main area of operation of the terrorist group are,
  - b) whether the country or regional authorities support the terrorist group economically or systematically,
  - c) whether sufficient economic sanctions or militaristic approaches were taken by those Member States and regional authorities,
  - d) whether the organizations written in article 6-b incited the attack;
21. *Encourages* the CTC, to announce the state where, through the investigations described in Article 6, has been recognized terrorist organizations or these have engaged in public;
22. *Urges* the CTC to regularly submit reports to the UN about issues stated in Article 6 and 7;
23. *Calls upon* the CTC, through the investigations described in Article 3, to recommend the below actions towards the Member States where terrorist organizations are or have engaged in:
  - a) that economic sanctions and militaristic approaches are taken towards terrorist organizations as soon as possible without threatening the lives and security of citizens,
  - b) that there is market control to prevent the influx of weapons and supplies into terrorist organizations,
  - c) that after detection, the progress of the regulation of the terrorist organization is reported to the UN General Assembly and the Security Council every three months (provisionally).
