Agenda item: Measures to eliminate international terrorism

The General Assembly,

Declaring that acts, methods, and practices of terrorism are contrary to the purposes and principles of the United Nations and that knowingly financing, planning and inciting terrorist acts are also contrary to the purposes and principles of the United Nations,

Emphasizing the fact that a definition about terrorist support states and terrorists agreed internationally have never existed and we have to make it,

Reaffirming the fact that preventing the occurrence of terrorism is better than taking measures to the terrorism after happening,

Recognizing the need for member states to complement international cooperation by taking additional measures to prevent and suppress, in their territories through all lawful means, the financing and preparation of any acts of terrorism,

Emphasizing the need to combat threats to international peace and security caused by terrorist acts by all means,

Emphasizing the necessary to continue the process which is confirming current situation and amending resolution for keeping the effect of abolition of terrorism,

1. *Calls upon* member states as follows;
 - (a) To establish a third party;
 - (b) To request the third party to define “terrorist support states”;
 - (c) To request the third party to define “terrorists”;
2. *Requests* member states to prevent terrorism in advance as follows;

- (a) To join Global Terrorism Counter Forum if they haven't joined yet to encourage sharing the information about terrorists between member states;
 - (b) To tighten security at border to prevent terrorists to acquire funds, weapons and combatants;
3. *Calls upon* all member states to help victims of terrorism financially, mentally and physically as follows;
 - (a) To establish a fund;
 - (b) To contribute money based on GDP ratios and financial conditions;
4. *Calls upon* all member states to take measures to the terrorism which has already happened as follows;
 - (a) To conclude an extradition treaty which runs if the accused isn't political prisoner and each country admit the accused's crime each member states;
 - (b) To encourage member states which comes under attack by the terrorists to impose economic sanctions which supports them in accordance with the Charter of the United Nations;
5. *Requests* all member states to tighten financial regulation of terrorists domestically as follows:
 - (a) Freeze the terrorists' assets in their country to prevent terrorists to use for improving their military force and increase occupied areas;
 - (b) To punish companies dealing with terrorists;
6. *Encourages* all member states to take all necessary steps in order to ensure the full implementation of this resolution and remain seized of this matter, as follows.
 - (a) To hold a meeting with all member states involved every year;
 - (b) To confirm the status of achievement;
 - (c) To amend the resolution according to the situation;
7. *Calls upon* a creation of a global definition of terrorism and terrorists by the general assembly;
8. *Requests* for a global definition for inappropriate posts on the internet by the general assembly;
9. *Urges* the creation of laws, regulating these posts considered inappropriate by a global standard;
10. *Requests* that after the definition of terrorism is confirmed, a third-party organization, CTC, will inspect the extradition and prosecution of terrorists;
12. *Encourages* ICC to judge the criminals after a global definition of a Terrorist is determined in the future;
13. *Urges* all countries to prohibit posts and sites on the internet encouraging people to commit terrorism or join terrorist groups, after a global definition of the terrorism and terrorist is created.
